

# Get Fresh Direct – Win a Year’s Supply of fresh produce

## Terms & Conditions

### 1. Promotional Period

- 1.1 Armidale City Bowling Club (ACBC) “Win a Year’s supply of Fresh Produce” promotion (“Promotion”) commences at 9am on the 26<sup>th</sup> December to 7:59pm on the 25<sup>th</sup> March with the draw on Friday 25<sup>th</sup> March at 8pm.

### 2. Entry Requirements

- 2.1 Entry is open to all financial members of ACBC and is via:  
**Entrance Terminal Barrel** - Swiping a membership card at the clubs entrance terminal during the promotional period. Members will be entitled to one (1) entry per day.
- 2.2 Members gaining entry through an entrance terminal must place their entry tickets in the **Win a Year’s Supply of Fresh Produce** before the draw date to be eligible. The barrel will remain full for the entire promotional period.

### 3. Draws and Prizes

- 3.1 There will be One (1) draw conducted from the **Win a Year’s Supply of Fresh Produce** on the following date: Friday 25<sup>th</sup> March 2022
- 3.2 For the draw there will be 1 (one) winner drawn out of all entries in the barrel. The winner will be given 4 (four) minutes to make themselves known to drawer. The winner’s name and membership number will be announced over the Clubs internal PA system.
- 3.3 If the winner is not present after 4 minutes the prize will be again drawn, and this will continue until a winner is present.
- 3.4 There will be one (1) major prize, provided by ACBC which provides the winner with one (1) Prize to the value of \$3000 made up in gift vouchers to the winners choosing from Get Fresh Direct and Get Meat Direct OR the winner may choose to take \$2500 as a cash prize
- 3.5 Only one prize will be given away

### 4. Identification

- 4.1 Winners must be present to claim their prize and they must produce a financial membership card to claim their prize.

### 5. General

#### General

- 5.1 Prize winners are advised that Tax implications may arise from their prize winnings and they should seek independent financial advice prior to the acceptance of the prize.
- 5.2 ACBC is the promoter. The promoter reserves the right to refuse to allow a winner to take part in any or all aspects of the prize, if the promoter determines, in their absolute discretion, that a winner is not in the mental or physical condition necessary to be able to safely participate in the prize.
- 5.3 ACBC reserves the right to cancel or change the prizes offered under this promotion if there are any changes to the law which would render the promotion, or any prizes offered under the promotion unlawful
- 5.4 It is a condition of accepting the prize that the winner may be required to sign a legal release in a form determined by the promoter in its absolute discretion.

- 5.6 To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, ACBC reserves the right to make a decision regarding such a situation or issue in its sole and absolute discretion and such a decision will be final and binding.
- 5.7 ACBC Management and staff members are not eligible to participate in the Promotion.
- 5.8 Participation in the Promotion by a patron confirms acceptance of the terms and conditions of the Promotion and the Club's Rules and By-Laws in force from time to time.
- 5.9 Should a prize winner consent to having his/her photograph taken, that selected prize winner consents to having his/her name and photograph published in any form of media and agrees to participate in any reasonable promotion requested by ACBC.
- 5.10 If for any reason this promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the promoter, which corrupt or affect the administration security, fairness or integrity or proper conduct of this promotion, the promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process.
